Because GSP terminated on October 1, 2001, and no decision had been made regarding the acceptance of Country Practice Petitions for the 2001 Annual Review, this list incorporates both the GSP Country Practice Petitions filed in the 2001 Annual Review and the GSP Country Practice Petitions filed in the 2002 petitions (regarding Czech Republic, Hungary, Poland, and Slovenia) on October 25, 2002. Ukraine was suspended effective August 24, 2001; Slovenia graduated effective January 1, 2002; and DaimlerChrysler Corporation withdrew its Market Access Annual Review. There are three exceptions - the suspension of a country and the graduation of a country from GSP, and the withdrawal of petitions. The
