INTRODUCTION
(993 AFLCIO

The AFL-CIO is pleased to submit its eighth petition under the worker rights provisions in the Trade Act of 1974, as amended. The 1985 adoption of these provisions promised the opportunity to document flagrant abuses of internationally-recognized worker rights. The internationally-recognized worker rights enumerated in the law include:

- the right of association;
- the right to organize and bargain collectively;
- a prohibition on the use of any form of forced or 0 compulsory labor;
- a minimum age for the employment of children; and,
- acceptable conditions of work with respect to minimum 0 wages, hours of work, and occupational safety and health.

Reference was also made to the ILO Conventions, which serve to elucidate precisely what activities are included in each of these basic worker rights.

AFL-CIO continues to believe there is a critical difference between the law and the practice of governments and that investigations must examine not only whether a particular government has laws in place allowing for worker rights but whether that government in practice executes necessary regulations to support these rights.

### Government Decisions

As of the date of this filing, no results on the 1992 cases. have been released. Therefore, the AFL-CIO reiterates its call for termination of GSP benefits for Bahrain, El Salvador, Fiji, Guatemala, Malawi, Oman, Panama and Thailand.

#### 1993 Cases

In addition to the eight countries in our 1992 petition, the AFL-CIO believes that violations of internationally-recognized worker rights are found in Costa Rica, Dominican Republic, Haiti, Malaysia, Maldives, Morocco, Pakistan, Paraguay, and Peru. these countries should not be AFL-CIO believes beneficiaries of the Generalized System of Preferences. Detailed information is provided on the new cases.
